There was a bit of concern over receiving scorecards via social media's, but he stated that he would confirm receipt if that would please people. If a submission is sent via this method and he fails to receive it, the sending captain should still have the evidence that could be shown to Phil at the next meeting.

The landlord of the Peterborough Arms in Dauntsey said that he had room for teams wishing to play there and to contact him if interested.
